Conditions of Entry

1. The Grafton Jacaranda Festival Committee Inc. reserves the right to accept or reject any entry and/or to restrict the number of entries in any section.
2. **ALL VEHICLES MUST BE REGISTERED** or carry a permit and comply with the requirements of the motor traffic act. All drivers must be licensed.
3. **NO ARTICLE OF ANY NATURE INCLUDING WATER** may be thrown or handed out from any vehicle. The use of Water Pistols is **PROHIBITED**.
4. You are requested **NOT TO CONSUME ALCOHOL** whilst participating in the process.

Please note:

Due to traffic congestion at the corner of Prince and Dobie Streets, MARSHALLS WILL BE LOCATED AT THE CORNER OF ARTHUR & PRINCE STREETS from 3:30pm where floats will enter the Marshalling Area and will be allocated numbers.

Positions and information will be available from members of the Big River Lions Club. The Procession will move off at 5pm. Floats arriving late at the Marshalling Area will be positioned at the end of the procession and will not be judged.

ALL FLOATS involving CHILDREN must marshal in the PARK between Hoof and Arthur Streets until ALL CHILDREN ARE SAFELY ON BOARD. People dropping off before or picking up children after the parade from these floats should enter the park via Hoof Street.

Clarence Valley Council has instructed this Committee that for safety reasons all entrants using SEMI TRAILERS in the Grand Float Procession must provide an adult person to walk beside the front of the semi trailer on the passenger side for the length of the Procession.

JUDGING by a panel of Judges located adjacent to the Clock Tower will take place during the procession.
